### ORDER

1. Vide paper read (1) above, University invited applications for Continuation of Provisional Affiliation for the academic year 2025–26 from the colleges for the courses affiliated to the University.
2. In response to the same, Principal, MVR Ayurveda Medical College, Parassinikadavu, Kannur vide paper read (2) above submitted their application for UG & PG courses as mentioned below with necessary documents.

3. Subsequently, University conducted an inspection at the college to assess the facilities available for conducting above mentioned courses with requested intake and inspection commission submitted its report vide paper read (3) above.

4. Vide paper read (4) above, the scrutiny committee verified the inspection report and found satisfactory. Thereby, scrutiny committee recommended for granting Continuation of Provisional Affiliation to the college for conducting courses with requested intake for the academic year 2025-26.

5. The above recommendations of the scrutiny committee were placed in the 84<sup>th</sup> meeting of the Governing council and vide decision read (5) above, Governing council resolved to grant Continuation of Provisional Affiliation to MVR Ayurveda Medical College, Parassinikadavu, Kannur for conducting UG & PG courses with requested intake mentioned in the table, for the academic year 2025-26, on the basis of recommendation of scrutiny committee and subject to the receipt of letter of permission from the Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India.

6. Vide paper read (6) above, the President, Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India has granted extended permission to Parassinikadavu Ayurveda Medical College, Pariyaram Kannur with 60 seats in UG BAMS and 13 seats in 03 PG courses as mentioned in the above table, under section 28 of NCISM Act 2020, for the academic session 2025-26.

7. Accordingly, orders are hereby issued granting Continuation of Provisional Affiliation to MVR Ayurveda Medical College, Parassinikadavu, Kannur for conducting UG & PG courses in Ayurveda (including B.Sc. Nursing and B. Pharm Ayurveda ) with requested seats as mentioned in the above table for the academic year 2025-26.

8. The college shall strictly adhere to the following conditions detailed below :-

- The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG& PG courses during the AY 2025-26 vide letter read (6) above.
- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.



- In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the college will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2025-26. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- The college should remit balance annual administration fee fixed for UG/PG course for the academic year 2025-26.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
